- 1. RULES/REGULATIONS: USER represents to GREG'S that USER has been instructed in the safe and proper use of GREG'S equipment. USER also represents to GREG'S that all of USER's employees and agents who use GREG'S equipment will be properly trained in the use of said equipment and will have the opportunity to view the CFN Cardlock Safety/System Training Video provided to USER by GREG'S. USER agrees to defend, indemnify and hold GREG'S free and harmless from any claims, action, losses, damages, injuries, liabilities and cost (including attorney's/legal fees) resulting from negligence or misuse of GREG'S property and equipment by USER and USER'S employees or agents.
 - a. USER and USER's employees and agents will comply with the following:
 - i. Smoking is prohibited within **50 feet** of dispensers.
 - ii. Dispensing fuel into any container not approved be the Fire Marshal is prohibited.
 - iii. Fueling vehicles with pilot lights operating is prohibited.
 - iv. Engines must be turned off before fueling.
- 2. TRANSACTION CHARGES: USER hereby accepts the obligation and responsibility for payment for all charges registered to cardlock access cards issued to USER. USER is liable for all transactions made on a lost or stolen card for up to 24 hours for GREG'S owned sites and up to 48 hours network wide after GREG'S has been notified that the card has been lost or stolen. Notification may be made verbally but must be confirmed in writing and received by GREG'S at P.O. BOX 307, Delano, CA 93216.
- 3. <u>CARD ORDER:</u> GREG's may recommend card/driver limitations, restrictions, labeling procedure, and delivery method of cards. **USER** automatically forfeits eligibility for fraud or theft coverage if **USER** chooses not to follow the recommendations given.
- 4. **ACTIVATING THE WRONG PUMP:** Should **USER**, **USER's** employee, or agent activate the wrong fuel pump, **USER** agrees to clear the pump before proceeding. **USER** agrees to be responsible for any fuels as the result of not clearing the pump that was activated in error.
- **5. COMMERCIAL ACCOUNTS: USER** represents that all fuel purchased will be for commercial business purpose only, and not consumer purpose.
- 6. LOCKED OUT ACCOUNTS: If USER's account is locked out for reason of delinquency, all monies plus a reactivation fee of \$25 must be paid before the account is reactivated. GREG'S reserves the right to refuse to reactivate any account that has been locked out due to delinquency. If USER's account must be referred to collections, USER agrees to pay collection cost and attorney's fees incurred by GREG'S.
- 7. <u>FUEL PRICES: USER</u> understands that **GREG'S** fuel prices are not displayed on any pump at the time of fueling.

- 8. AGREEMENT TERMS: Terms of this agreement are subject to change upon written notice by GREG'S to USER. If USER uses any cards after receipt of such notice, then USER's consent to change terms shall be implied.
